# AGM 2021 - Minutes

Minutes of the Annual General Meeting held at 12 Noon on Thursday 11 February 2021.

Present: Mr David Gilmour, President in the Chair; Prof Stephen Hillier, Vice President; Mrs Oonagh Gray, Immediate Past President; Mr David Lamb, Hon. Secretary; Mr Finlay Marshall, Hon Treasurer; Mr Peter Freshwater, *Journal* Editor; Mr John Sutherland, *Journal* Assistant Editor; Mrs Joan Meikle, Assistant Secretary; Prof Ian Campbell, Lady Lucinda Mackay, Mr Alan Pearson, Mrs Christine Reid, Dr Essie Tough and Mr Ritchie Walker.

The President welcomed everyone to the meeting, the first ever to be held via Zoom. He gave a special welcome to Mr Alan Pearson who could attend from Ontario, Canada, due to the meeting being held online. There were no apologies.

1. Minutes and matters arising: The President drew attention to an error in the minutes of the previous meeting and said that the correct title for one of those listed in Apologies should be **Dr** Michael Langdon. Having taken account of this alteration, the minutes of the 2020 Annual General Meeting were approved as an accurate record of the meeting. They would be signed by the President at a later date, once the restrictions on travel imposed by the Coronavirus pandemic, were lifted. This was agreed.

The President said that no meetings with Development & Alumni (D&A) had been held this year as all staff at D&A were working from home and face-to-face meetings were not permitted meantime. It was hoped that meetings would resume whenever it was possible, perhaps some time later in the year.

2. Finance: Mr Marshall began his report by stating that the Accounts to 30 September, 2020 which had been circulated in advance of the meeting, had not yet been seen by the Hon Accounts Examiner and added that the Accounts as presented were for adoption subject to there not being any significant differences identified as a result of the Independent Examination.

He was pleased to report a far better outcome than he did at the AGM last year.

At that AGM, there were proposals presented and passed to increase the Annual Subscription and introduce

explicit charges for paper versions of the *Journal*. The effect of these changes had not yet emerged.

The principal reason for the improved financial state was the amount of Donations. He had commented before regarding the place Donations take in the financial state of the Association. He had never been associated with an Association whose members voluntarily support it to the extent identified by the Accounts. Thanks were due to all who had made donations, and special thanks to a few who made significant, indeed extremely generous, donations. Clearly those donors wished to see the Association, or at least the output of the Association, continue, as do we all.

The Executive Committee recognise the need not to be dependent on donations and took steps at last year's AGM to address matters. Next year's Accounts should begin to show to what extent this has been successful. While we introduced an explicit charge of printed versions of the *Journal* that change will come into effect only from the Summer edition this year.

All members, whether they had elected to receive the recent Winter edition of the *Journal* printed or online, received it in printed form, that edition being the final instalment of Volume 49. The change, according to subscription choice, would come into effect from the beginning of Volume 50. Next year's Accounts therefore would reflect the subscription change in full, but only half of the savings expected in the publication and distribution costs.

In this year's Accounts, Annual Subscriptions continued to show a reduction year on year, due to a reduced number of annual subscribers, 343 reducing to 327. The Committee recognises the need to increase the Association's paying membership, and indeed, to grow its membership generally.

Last year's Accounts, and indeed activities, were heavily influenced by the emergence of the coronavirus. Our principal event of the year, the Annual Reception & Dinner was the last function organised that took place. This had been preceded by our biennial St Andrew's Day Dinner, as well as a Christmas Lunch. In future years, it is the intention to hold these two functions in alternate years.

Usually, the Revenue from functions fluctuates, depending on whether the Association holds a St Andrew's Day Dinner or not. Last year, this event was held, and it would have been expected in the normal course of events that Revenue from functions last year would have shown a marked increase from the previous year. The restrictions brought in as a reaction to the COVID-19 pandemic, curtailed our Events programme. The slight reduction,

from £5,903 to £5,260 rather disguises the extent of the reduced activity.

This reduced activity, coupled with the advice from Government to lockdown where possible made it comfortable for the Association to accommodate the furloughing of one of our staff members. This was a mutually agreed decision. Neither Mrs Meikle, our Assistant Secretary, nor the Executive Committee wished to impose conditions likely, or possibly likely, to endanger her health. While on furlough, her salary was maintained in full: the reduction in Wages & Salaries shown largely reflects the impact of the Grants received from HM Government.

Mr Marshall concluded his report by saying that the Accounts were very much as would have been expected of a stable-on going organisation and were effectively unchanged from last year.

The President thanked Mr Marshall for his report and invited questions and comments.

Mr Walker queried the sum of £4,500 in Current assets-debtors and was advised that this related to the Grant received from the University which did not come to hand until 1 October, the day after the end of the financial year and thus too late to include in its usual place in the accounts. Mr Walker observed that the University Grant had remained constant at £4,500 for some years and suggested that it was time to apply for an increased amount. Mr Lamb responded by saying that the negotiations with D&A had been the unforeseen consequence of the University's response to his letter in January 2019 requesting an increase in our Grant.

Professor Hillier added that the University had suffered significantly financially through a reduction in income due to the cessation of their events. Any application to the University for additional funding would need to be accompanied by the highlighting of resulting benefits to the University as a consequence. Professor Hillier said that the approaching Centenary of the Association in 2023 and of the *Journal* in 2024 could be the reason for a request for additional funding.

The President said that the Executive Committee would look at this again.

Mr Walker said that producing a calendar for the Centenary could be a promotional and fund-generating exercise.

The Accounts were proposed for adoption by Mr Finlay Marshall and seconded by Mr Peter Freshwater, subject to there being no material alterations imposed by the Accounts Examiner.

The President thanked Mr Marshall for his work with our finances this past year and especially for coping with the changing circumstances together with the need for obtaining grants from HMRC.

**3. Editorial Committee Report:** Mr Freshwater reported that the Editorial Committee had met twice during 2020, in March and October and met again in February 2021. He was sorry that Mr Jack McLaren had resigned from the Committee and thanked him most warmly for all his contributions to Committee business and support for the *Journal* over the last few years. The Committee now had two vacancies and would seek to fill them by invitation and co-option.

Two issues of the University of Edinburgh Journal, for Summer and Winter 2020, were published on time and within budget at a cost of £4,292.95 for Summer and £4,157.40 for Winter and were distributed to members and to other recipients. They had been well received. Both issues were prepared by the Editorial Team working from home and who have been unable to gain access to the Association office during COVID-19 lockdowns. He was grateful to the printer, Cambrian, in Aberystwyth for being able to print and distribute both issues with their reduced staff, and to our printing adviser Mr Steven Hansen-Just for helping us with this. As reported last year, we have reverted to the original practice of dating Journal issues according to seasons, Winter and Summer, to allow a degree of latitude in publication and distribution if needed, as it was in December. It was proposed that from 2022, publication of the Journal would be in the Spring and Autumn rather than in Summer and Winter, as this would fit more appropriately into the academic year. The Editorial Team was again grateful for assiduous proof reading by several members of the Editorial Committee.

The present cover design was retained for both issues, which have completed Volume 49. The Editorial Committee has agreed that the first issue of Volume 50, and the run up to the Centenary Volume in 2024/2025, provided a good opportunity for redesigning the layout of the *Journal* and the design of the cover, and was keeping possible developments under review. It has also agreed that the Association's administrative information be moved from the *Journal* to a separate Members' Newsletter, to be accessible on the Association website and sent out by email, with printout copies available to members who wish to receive them in that way. Many members have indicated that they wish to receive the *Journal* online in a PDF format rather than (or in some



cases, as well as) print, and this has enabled us to reduce the number of printed copies and the cost of postage. He encouraged any members who had not yet contacted us regarding their subscription preference to do so as soon as possible.

Mr John Sutherland, Assistant Editor, had scanned a further ten back volumes of the Journal, Volumes 19-25 for the years 1958 to 1972 and would shortly be adding them, along with Volumes 45-49, for the years 2011 to 2020 (which have already appeared in PDF format) to the Archive at http://www.uega.co.uk/archive. The Archive complements the Association's Facebook page https://en-gb.facebook.com/uegradassoc/, which the Editor endeavours to keep supplied with news from other parts of the University. More members of the Association were again encouraged - indeed, urged - to visit and use both as often as they could, and themselves to add more and different contributions. The more frequent the usage, the higher the priority that the search engines would give these two online addresses.

As Editor, Mr Freshwater had great pleasure in recording gratitude to Mr John R Sutherland, Assistant Editor, Professor Ian Campbell, Convener, and all the members of the Editorial and Executive Committees for their support and commitment over the year. The President added his thanks to those of Mr Freshwater.

Mr Alan Pearson said that as the University was keen to build the Club network, the Ontario Club of which he was a member having been in existence for over 50 years, he suggested that the Journal should be distributed to Clubs around the world and would give the University the opportunity to engage with graduates. He suggested that this alone should be sufficient to justify an increase in the Grant payment. He said that EU graduates living in Toronto were favourably disposed towards Edinburgh and enjoy reminders of their time there. Receiving something tangible from the University would be a good connection.

Mr Walker referred again to the production of a calendar and suggested that the University might be willing to sell copies on our behalf which wouldn't be in competition with other University publications. The calendar too was a good link to the University and he thought that the University would be willing to support it.

Mr Freshwater replied that there were no immediate plans to produce a calendar which would take two years to get to completion. He was aware that there would be competition with other calendars although it would be the intention to aim to produce the University calendar. Much experience had been gained from the production, sale and marketing of the previous calendar in 2018 and this would need to be developed further.

Mr Walker suggested that the two Committees should look into this again at their next meetings.

4. President's Report: Mr Gilmour said that this had been an unprecedented year for the Association. During this past year just the one event was held for members – the Annual Reception and Buffet Supper in March 2020. It was a very enjoyable event and the after-dinner speaker, Mr Lukas Svoboda, gave an excellent and well-illustrated talk about his concern for the diminishing population of big cats. Our Members' Lunch in April was cancelled, we did not visit the refurbished Law School premises as planned in May and the visit to Abbotsford House was postponed until June 2021. It seems as if we will not be allowed much social contact for the foreseeable future and he suggested that our visit should be postponed for yet another year - to June 2022. To date, and not very surprisingly, no tickets had been sold for this outing so it would be easy to arrange a postponement. This was agreed and Mrs Meikle would attend to the re-booking.

No other events or meetings had been planned and the regular Coffee Mornings, held on the first Saturday of the month, were not taking place meantime. Social events for members would be re-started as soon as possible.

The annual Service of Remembrance was not held in quite the usual manner in November and, due to the present circumstances, the President laid a wreath on behalf of the Association on the Thursday prior to Remembrance Sunday.

Again, no new membership campaign had been conducted due to the restrictions imposed by GDPR. As at 30 September 2020, our membership was now 956 members.

Professor Hillier expressed his concern at the reduction of nearly 100 members since last year. He said that we must do something to address this as the total membership is decreasing year on year.

Mrs Gray said that we were losing touch with our members during the pandemic and she hoped that lunchtime lectures could be set up via Zoom. The President said that this would be looked into.

Mr Freshwater said that lecture type events could be offered but would need to be looked into. They could be hosted from the office but having staff on furlough has added some complications.

Mr Walker thought that lectures could be made more widely available than just to members. Speakers who were willing to use Zoom could be easily found.

Mr Sutherland said that three talks about the history of the University could be used but that they would need to be pre-recorded.

The President agreed that this would be referred to the Executive Committee to be discussed further.

Mr Pearson suggested that D&A might be willing to publicise these talks to the overseas Clubs which could provide support for them. A small charge to watch them could be levied.

Mr Freshwater agreed to look at how the suggested lectures could be produced as there were a number of alternatives. He thought that they perhaps shouldn't be UK lunch time events and that recording and streaming would provide more flexible viewing opportunities.

Mr Sutherland questioned whether lectures would appeal to current students. He thought that a webinar might be possible.

Mrs Gray was keen to support anything that would keep members in touch and which might involve them. Many clubs were doing much more than we were to keep in touch with their members in these unusual times of Covid restrictions.

5. Election of Honorary Office-Bearers: President -Mr Gilmour was willing to continue in office for the second year of his appointment; Vice President - Professor Stephen Hillier would continue for the second year of his elected term; Honorary Secretary - Mr David Lamb was willing to continue in post; Honorary Treasurer - Mr Finlay Marshall was willing to serve for one more year in this post and had indicated that he would not be willing to stand for re-election at the AGM in 2022, although Mr Marshall added that he might be persuaded to serve one more year if necessary.

The above were appointed without dissent.

- 6. Appointment of Honorary Accounts Examiner: Mr Eric Brown holds this position and had indicated that he was willing to continue in this post. This was agreed unanimously.
- 7. Executive Committee Elections: There were no retirals from the Executive Committee this year, although two new committee members were elected at the AGM in 2016. Of those, Mr William Buchan resigned at the AGM in 2019 and Mr Gilmour now occupied the role of President. Notification of his resignation from the

Executive and Editorial Committee had been received from Mr Jack McLaren

Mr McLaren served two terms on the Executive Committee from 2011, which included a term as Vice President from 2014 to 2015 and again on the Executive Committee from 2018. The President thanked him most warmly for his invaluable contribution to the work of the Association on the Executive Committee and also as a helpful member of the Editorial Committee.

No nominations had been received from anyone willing to serve and the Executive Committee would use their powers to co-opt if a suitable volunteer was identified during the coming year.

8. Any Other Competent Business: Mr Walker said that there was a need for younger members to be part of the Editorial Committee. Mr Sutherland agreed that the membership of the two Committees was presently too similar and that there should be different people serving on each Committee. Prof Hillier suggested that overseas members could be invited to be committee members now that meetings were being held on Zoom. Mr Pearson thought that could be possible although he said that it was presently 6am in Ontario.

Mrs Gray said that the University's outgoing Rector, Ann Henderson, had offered to write an article for the Journal about her experiences as Rector. Mr Freshwater welcomed this offer with enthusiasm and said that he would write to the new Rector, Debora Kayembe, welcoming her to this role when she took office from 1 March 2021.

9. Date of Next Meeting: The next Annual General Meeting would be held on Thursday 10 February 2022. It was agreed that the meeting would be held in the Raeburn Room at 12 noon with a sandwich lunch to follow but that the meeting should also be available for members to attend via Zoom. The meeting closed at 12.55pm with thanks to the Chair.

## Recent Deaths of Members

The last few months have been saddened by the deaths of three former Association officers of long standing. Our former Patron and former Chancellor of the University, HRH The Prince Philip, Duke of Edinburgh, died on 9 April 2021, at Windsor Castle, aged 99. An appreciation of his Edinburgh University years, and a reprint of his inaugural address to the University, both appear in the Summer 2021 Journal. Joyce Richardson, who served for several years as Honorary Secretary of the Association, and for many more years as a member of the Executive and Journal Editorial Committees, died on 3 June 2021 in Edinburgh, aged 88. Jean R Guild, who served for many years as Assistant Editor and then Editor of the Journal, and a term as Vice-President of the Association, died on 4 June 2021 in Edinburgh, aged 93. # Kathleen Jamie is the New Scots Makar

he poet and essayist Kathleen Jamie, who is also a philosophy alumna of Edinburgh University, has been appointed Scots Makar

by the Scottish Government, in succession to Jackie Kay, Liz Lochhead, and Edwin Morgan. She is expected to hold the post for four years. # Alistair Kerr's Tales for Twilight

letter to the Editor from graduate of the ✓ **\**University of Edinburgh, Mr David R Anderson.

Dear Editor,

I agree entirely with your editorial in the Summer 2021 edition of the University of Edinburgh Journal. I am a law graduate of the University of some sixty years standing, as a student a holder of the Dalgetty bursary in Constitutional Law, and among other legal practice positions a retired part-time judge. As such, I was appalled to read of the experience of a sixtyyear-old lecturer who was wrongly attacked online by students alleging racism, misogyny, and transphobia after he criticised a move to change the name of the David Hume Tower. He also raised concerns about a campus event called Resisting Whiteness, regarding an area exclusively for people of colour. He was accused of being a "rape apologist", and students bizarrely claimed they did not feel safe in his classes. A two-month investigation exonerated him; yet his false accusers faced nothing. That is the aspect of the matter that damns the University authorities. I agree with the lecturer's comment that "the message the university is sending out is that the students can do exactly what they like and we are too scared to challenge them. That's a terrible way of educating students". Quite.

In my student days, behaviour of this nature would certainly not have been tolerated; and, if established, would have been visited with serious consequences. What can we as graduated do about it now? Certainly we must make our views clear to the University authorities; but there is one practical way in which we might back that up. In the past, I have on occasion contributed reasonable sums of money to the University when approached with begging letters from senior management seeking funds for particular projects; and I have made some provision for the University in my will. The University is dear to my heart — after all, it gave me the means to earn my livelihood. But freedom of speech is also dear to me as a lawyer, and it can be a complex matter. The Development Trust is always looking for money, and normally I am happy to respond. I am sure that many of my fellow graduates will be in the same position. However, given the present situation, I for one may have second thoughts about financial donations in future if the University authorities persist in their lack of action on this matter. If we collectively made it clear to those at the top that they may be putting some element of financial support in jeopardy, that could have some effect. The one thing they seem to react to with some alacrity these days is to money — or possibly the lack of it. While one individual graduate donation withheld may not make much difference to the university finances, the sum total of all such donations world-wide must add up to quite a substantial sum and might leave a bit of a hole in the finances. If we were to club together in a "withholding funds" campaign and let the authorities know about it in advance, they might just pay some attention.

I am conscious of the counter argument against financial "sanctions", namely that such measures would harm or at least do a disservice to the University. But is such harm any greater that the present damage caused by doing nothing? One would hope in any event that it would, if successful, be only temporary.

# Lady Lucinda L Mackay

ady Lucinda L Mackay was born in Berkshire in 1941 and brought up in South Ayrshire. She was educated at Châtelard School in Switzerland, and attended both the University of Edinburgh and Edinburgh College of Art, where she studied under Prof David Talbot Rice and Sir William Gillies. She graduated MA (Hons) in 1965. In 1974, Lady Lucinda completed her postgraduate studies at London's Central School of Art and Design. She now lives and works in Edinburgh, where she takes portrait commissions and holds exhibitions of her work.



In 1964, Lady Lucinda began her career by taking third place in an art competition to commemorate the opening of the Forth Road Bridge. She went on to exhibit a collection of East London Drawings and Prints at the Museum of the Home, Shoreditch, in 1974. She was commissioned by William Lloyd Webber, composer, to sketch his music students at the London College of Music and, in 1990, she was invited by Mrs Patricia Maxwell Scott to paint Walter Scott's house at Abbostford. In 1994, she won a drawings competition held by the National Museum of Scotland and, in 2003, the National Portrait Gallery bought her painting of Prof John Erickson. Lady Lucinda held an exhibition of her drawings in the New Club, Edinburgh, in April 2005 and, in September 2005, a double portrait of the Daiches brothers was unveiled at the Faculty of Advocates in Edinburgh's Parliament Square. The National Library of Scotland accepted a large amount of material

from Lady Lucinda for their archives in 2015. In 2017, she was commissioned to paint two portraits of Prof Sir Fraser Stoddart, Nobel Laureate in Chemistry. In 2020, Lady Lucinda painted a portrait of Sir Ian Wilmut with Dolly the Sheep. Her other notable painted and drawn portraits include: Rev Martin Hollingwoth, pianist, in 2020; Peter Shand, solicitor and pianist, in 2019; Prof Sir Timothy O'Shea, Principal of the University of Edinburgh, in 2013; and Prof Peter Higgs, Nobel Laureate in Physics.

In 2008, Lady Lucinda joined UEGA's Executive Committee and continued serving until 2016. In 2010 and 2014, she published articles in the University of Edinburgh Journal, and since 2013, she has served on the Journal's Editorial Committee. Her splendid drawing of the Old College is has been used as a central component of the Journal's style and appearance for many issues.
